He joined PIMCO in 1996 and previously served as PIMCO's global head of investment grade corporate bonds and as a senior credit analyst. He has 30 years of investment experience and holds an MBA from the University of Chicago's Booth School of Business and an undergraduate degree from the University of Michigan.
